That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with THE INTERNATIONAL BOUNDARY AND WATER COMMISSION for joint participation in a project to provide additional protection for the Emergency Sewer Connection with Tijuana, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 253392.

BE IT FURTHER RESOLVED, that the expenditure of \$216,500 is hereby authorized from Sewer Revenue Fund 41506 for the sole and exclusive purpose of providing funds for the project.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$216,500 within Sewer Revenue Fund 41506 from the Unallocated Reserve (70697) to Sewer Main Maintenance (70440).
