WHEREAS, The City of San Diego participates in the Areawide Water Quality Management Plan (under Section 208 of P.L. 92-500 as amended) prepared in cooperation with the San Diego Association of Governments and approval of the U.S. Environmental Protection Agency; and

WHEREAS, the Environmental Social and Economic Assessment prepared for the Areawide Water Quality Management Plan contained an assessment of the need for expanded sewage effluent disposal facilities, including the disposal of sludge; and

WHEREAS, the area of Piesta Island in Mission Bay,
San Diego was recognized in the Areawide Water Quality Management Plan as an interim repository for sludge produced by the
Metropolitan Sewerage System; and

WHEREAS, The City of San Diego is engaged in the planning, impact assessment, and design phases of a program intended to result in the upgrading and expansion of the entire Metropolitan Sewerage System, and a program which is funded in part through Section 201 of the Clean Water Grant Program; and

WHEREAS, the Council of The City of San Diego has expressed its deep concern for avoiding any adverse impacts on Fiesta Island and seeks full protection of all of the natural resources and public uses of Mission Bay; NOW, THEREFORE,

BE IT RESOLVED, that the environmental analysis of the improved Metropolitan Sewerage System shall include a detailed analysis of alternatives to the continued, temporary use of

Piesta Island as an area for sludge drying beds and that the interim sludge drying operations be conducted in a manner that minimizes adverse impacts to the public uses of Mission Bay and its resources including water quality, lands, and plant and animal life.

BE IT FURTHER RESOLVED, that the City Manager and Planning Director be and they are hereby directed to take such action as is necessary to accomplish the tasks set forth above.
