APPROVING MAP OF BIG SKY INDUSTRIAL PARK

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by MICHAEL J. ANDERSON, a Registered Civil Engineer, entitled "BIG SKY INDUSTRIAL PARK Being a subdivision of a portion of the south 1/2 of the Northeast 1/4 of Section 21, Township 18 South, Range 2 West, San Bernardino Meridian, according to United States Government Survey approved February 25, 1870, in the City of San Diego, County of San Diego, State of California, together with portions of Main Street and Hollister Street as dedicated to public use.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Alamitos Avenue, Manya Street, Manya Circle, Verus Street, a portion of Hollister Street and a portion of Main Street for public purposes; and said streets and portions of streets and hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Main Street, adjacent and contiguous to Lots 1, 2, 3, 4, 24, 25 and 26, excepting thereform access openings to Lots 2 and 3; in and

to Marian Avenue, adjacent and contiguous to Lots 12, 13, 14, 15, 20 and 21, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
