BE IT RESOLVED, by the Council of The City of San Diego, as follows:


Said Council hereby finds that that certain map surveyed by L. Curtis Larson, a Registered Civil Engineer, entitled "OCEAN VIEW TOWN HOMES Being a subdivision of Lots 3, 4, 5, 6, 7, 47, 48, 49, 50 and 51 in Block 2 of J. R. Spencer's Subdivision of Blocks 10 and 11 of Central Homestead, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 618, filed in the office of the County Recorder of San Diego County, December 7, 1889, together with a portion of 33rd Street, the Alley adjacent to Lots 48, 49, 50, 51 and a portion of Lot 47, in Block No. 2, all as being closed and vacated to public use.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of the alley for public purposes; and said portion of the alley is hereby declared to be a portion of a public alley and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public alley is accepted on behalf on the public as heretofore stated.
