VACATION OF A PORTION OF AN ALLEY

JAN 12 1981

WHEREAS, it is proposed that a portion of an alley located between Ocean View Boulevard and Martin Avenue be vacated; and

WHEREAS, there is no present or prospective use for a portion of an alley either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, California, that the portion of an alley located between Ocean View Boulevard and Martin Avenue, as more particularly referred to in Resolution of Intention No. R- 253237, is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that the portion of an alley located between Ocean View Boulevard and Martin Avenue, as more particularly shown on Drawing No. 14986-B on file in the office of the City Clerk as Document No. RR- 253237, which said Drawing is attached hereto and made a part hereof, be, and the same is hereby ordered vacated.

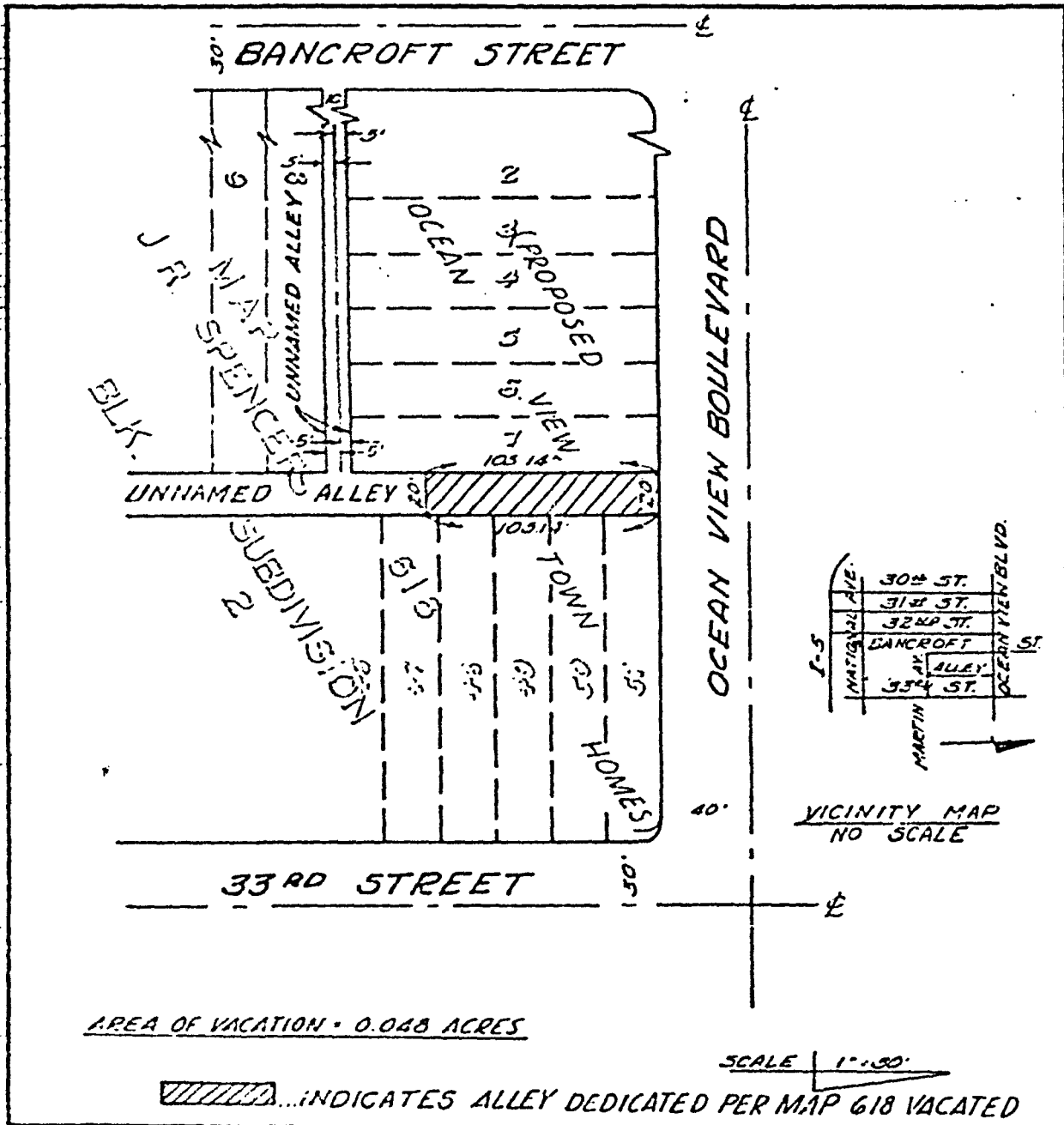
