

RESOLUTION No. R- 253420 (R- 81-969 )



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that easement deed of ROBERT E. MAYBERRY, a married man as his sole and separate property, executed in favor of The City of San Diego, bearing date of August 22, 1980, a copy of which is on file in the office of the City Clerk as Document No. RR- 253420, granting to said City an easement for a right-of-way for a public alley and incidents thereto, through, over, under, upon, along and across all that portion of Lot 18 in Block 13 of Bungalow Park Addition, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public alley.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution attested by him under seal to be recorded in the office of the County Recorder.
