BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the construction of certain improvements in the ALLEY bounded by AVENIDA CORTEZ, AVENIDA CRESTA and CAMINO DE LA COSTA, under the provisions of the Improvement Act of 1913, consisting of nine sheets and filed under Document No. D2229-1, is hereby granted.

That the City Manager be and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the conversion of existing overhead and communication facilities to underground locations within the public rights of way and on private property, in the alley bounded by Avenida Cortez, Avenida Crests and Camino de la Costa, in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvements hereinabove mentioned.
