BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$178,802.46 by JIM McNULTY, an individual, dba JIM McNULTY CONTRACTING for the IMPROVEMENT OF ROSE CREEK BIKEWAY in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the specifications on file in the office of the City Clerk as Document No. A-00145.
2. That the City Auditor and Comptroller is hereby authorized to transfer within Fund 39005 an amount not to exceed \$80,000.00 from CIP 58-014 to CIP 58-011.
3. That the City Auditor and Comptroller is hereby authorized to increase the Capital Improvement Program CIP 58-014 by \$133,000.00 from Local Transportation Fund.
4. That the expenditure not to exceed \$133,000.00 from Fund 39005 CIP 58-014 is hereby authorized for the purposes of executing this contract and related costs.
