BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of CARL BURGER'S DODGE WORLD is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of SIX (6) VANS AND ONE (1) FOUR-WHEEL DRIVE VEHICLE as follows: one (1) Police Lab Van at a cost of \$8,525.63; five (5) Community Service Officer Vans at a cost of \$8,602.23 each, for a total cost of \$43,011.15; and one (1) four-wheel drive vehicle at a cost of \$9,423.99; for a combined total of \$60,960.77; net 10 days, plus sales tax, less trade-in allowance as follows:
