BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and drainage easement deeds of BRUCE C. VAN HORN and ALMA M. VAN HORN, executed in favor The City of San Diego, bearing date of October 9, 1980, copies of which are on file in the office of the City Clerk as Document Nos. RR-253455-1 and RR-253455-2, conveying to the City permanent easements for street and drainage purposes affecting portions of Block 17 and Lot 1 in Block "A" of Wadsworth's Olive Grove Addition, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and Parcel 1 is hereby named QUINCE STREET, and Parcel 2 is hereby named CHOLLAS ROAD.

That the City Clerk is hereby authorized and directed to cause said deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
