WHEREAS, Ms. Evenson has been particularly concerned about the restoration of the Balboa Park Organ Pavilion; and

WHEREAS, in connection therewith, she has actively participated with the Committee of 100 in its endeavors to restore and maintain Balboa Park cultural facilities; and

WHEREAS, Ms. Evenson's latest act of generosity was to donate to the Committee of 100 the sum of \$131,000 for the restoration of the Organ Pavilion; and

WHEREAS, the Committee of 100 has accepted said gift and has agreed to match that sum, dollar for dollar, for the purpose of restoring the Organ Pavilion; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of itself and the citizens of the City, does hereby publicly commend Ms. Bea Evenson for her generous gift of \$131,000 to the Committee of 100 for the purpose of assisting in the restoration of the Organ Pavilion.
