

RESOLUTION NO. R-253479

APPROVING MAP OF WINDEMERE TRIANGLE

JAN 26 1981

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, a Registered Civil Engineer, entitled "WINDEMERE TRIANGLE Being a subdivision of Lot 24 of La Jolla Golf and Tennis Club Unit No. 2, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 8217, filed in the office of the County Recorder of San Diego County, California and that portion of Pueblo Lot 1254 in the City of San Diego, County of San Diego, State of California according to Map of the Pueblo Lands of San Diego made by James Pascoe in 1870 and Miscellaneous Map No. 36 filed in the office of the County Recorder of San Diego County November 14, 1921.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the open space easement over, under, upon and across portions of Lots 1 and 2, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that the open space easement, as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
