That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the STATE OF CALIFORNIA for the modification of the traffic control system at the intersection of Sports Arena Boulevard, Rosecrans Street and State Highway Route 209, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-253486.

BE IT FURTHER RESOLVED, that the expenditure of \$61,250 is hereby authorized from the Capital Outlay Fund in CIP 68-001 solely and exclusively for the City's share of the estimated costs associated with the project.
