WHEREAS, Board invited and reviewed proposals from six nationally known consultant firms; and

WHEREAS, Board selected, at its regular meeting of November 21, 1980, the firm of DeMarche Associates as most responsive to criteria established by Board; and

WHEREAS, Board now submits its selection for consultant and the necessary agreement to Council for approval so that the national search for investment counsel may proceed; NOW, THEREFORE.

BE IT RESOLVED, by the Council of The City of San Diego, that the President of the Board of Administration of The City of San Diego Employees' Retirement System be and is hereby authorized to execute an agreement with the consulting firm of DeMarche Associates, a Missouri corporation, for the purpose of conducting a national search for one or more investment

counselors as required by Section 144 of the Charter of San Diego for a six (6) month period commencing January 1, 1981, pursuant to the terms and conditions of that certain agreement on file in the office of the City Clerk as Document
