APPROVING MAP OF PLAZA MAYOR UNIT NO. 4

JAN 27 1981

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by ROBERT G. SCHOETTNER, a Licensed Land Surveyor, entitled "PLAZA MAYOR UNIT NO. 4 Being a subdivision of all those portions of Lots 1 through 48 inclusive, in Block 9 of Tia Juana City, together with those portions of Front Street, St. Louis Avenue, and the alley between said lots and streets, as vacated and closed to public use on October 11, 1890 by the Board of Supervisors of said County, all being in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 562, filed in the office of the County Recorder of said San Diego County, August 29, 1888, and together with New York Avenue as vacated and closed to public use. Excepting therefrom onehalf of all the oil, gas and mineral rights whether metallic or nonmetallic in and under said property as reserved by Central Liquidating Company in deed recorded July 19, 1944 in Book 1722, Page 59 of official records., "is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Camino de la Plaza for public purposes, and said portion of a street is hereby declared to be a portion of a public street and


dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of water facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as heretofore stated; and that the easement with the right of ingress and egress for construction and maintenance of water facilities, as granted and shown on this map, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
