WHEREAS, New York Avenue has been relocated through the creation of this date of the lot in the subdivision known as Plaza Mayor Unit No. 4; and



2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

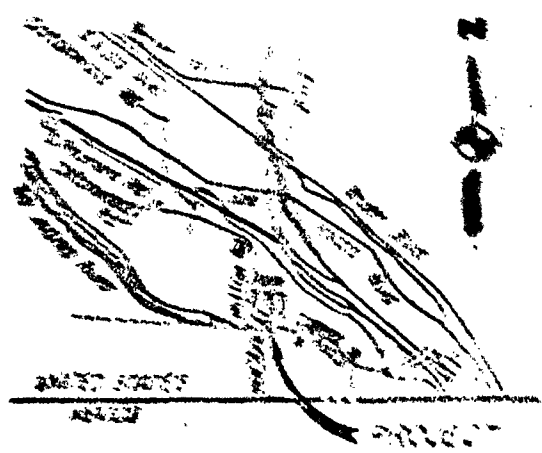

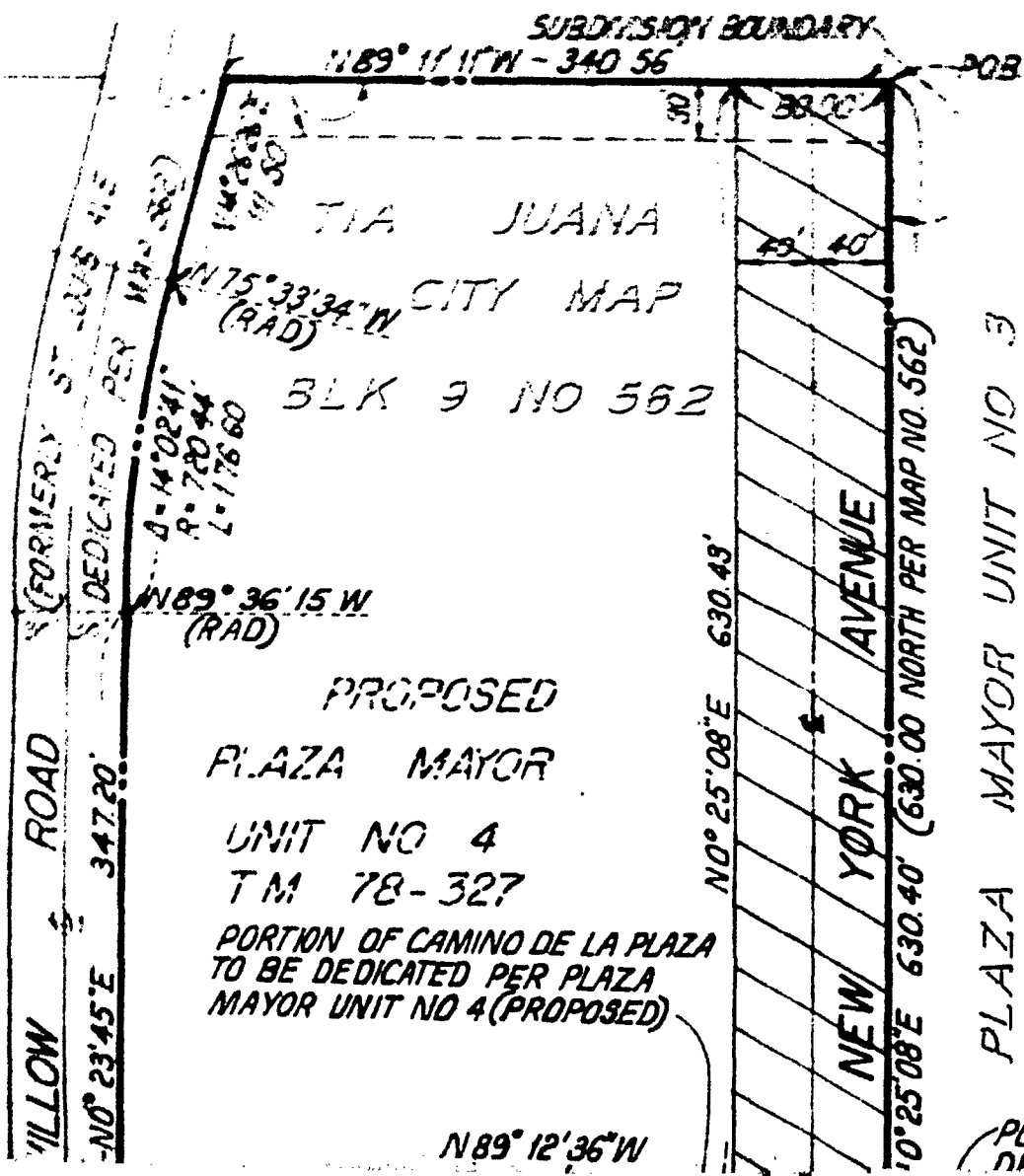
ADDITION 1 SAN YSIDRO MAP 1194

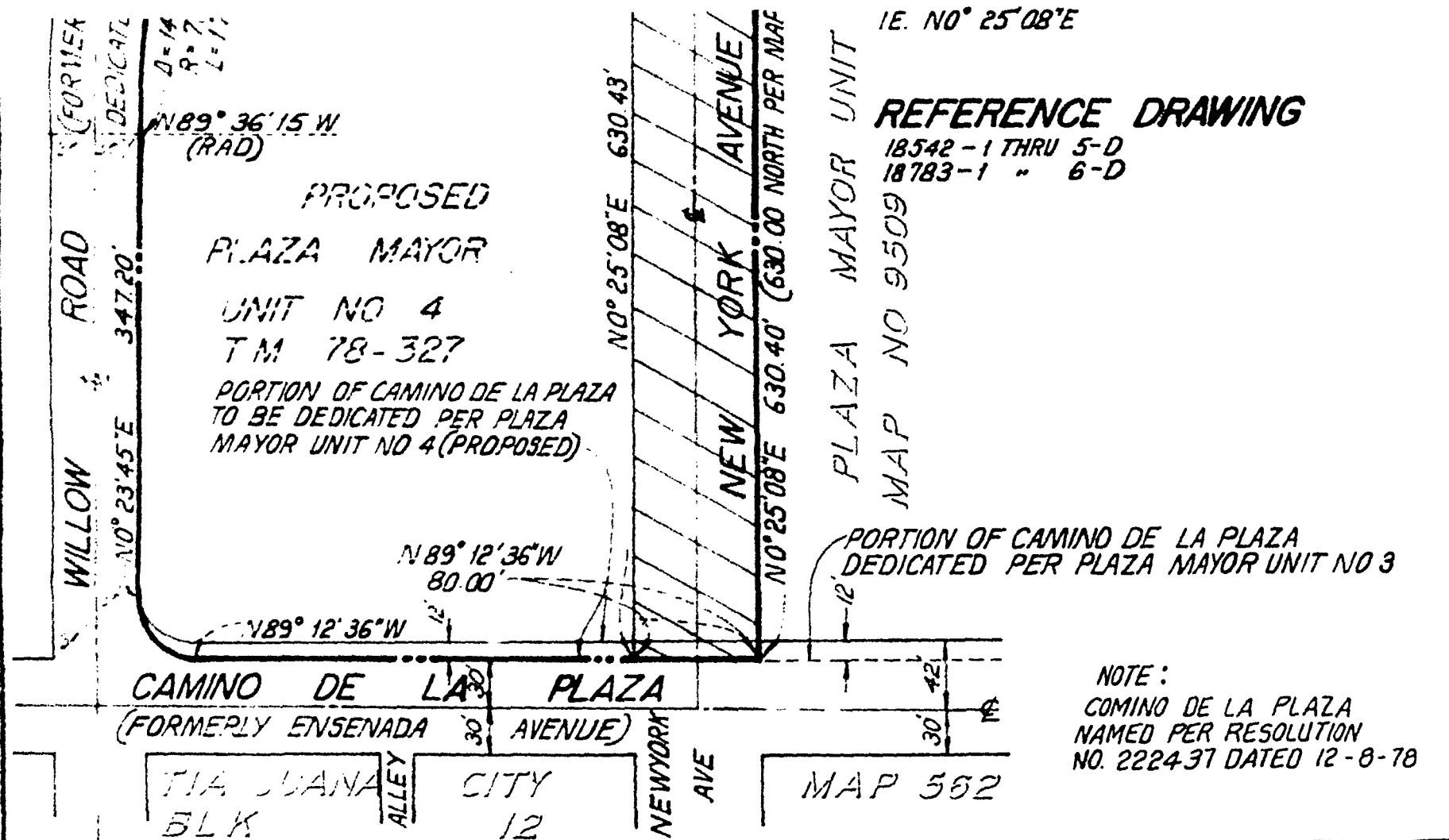
