BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street and alley easement deed of ODMARK/WELCH, a General Partnership, executed in favor of The City of San Diego, bearing date of July 1, 1980, a copy of which is on file in the office of the City Clerk as Document No. RR- 253529, granting to said City the permanent easement and right-of-way to construct, reconstruct, maintain, operate and repair a public street, including any or all appurtenances thereto, together with the right of ingress and egress, over, under, along and across all those portions of Lots 25 and 26 in Block 16 of Tia Juana City, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and Parcel A is hereby dedicated as an ALLEY, Parcel C is hereby named CAMINO DE LA PLAZA, and Parcel E is hereby named TIA JUANA STREET.

That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
