WHEREAS, portions of Camino De La Plaza, Virginia Avenue and Alley have been relocated by the acceptance on this date of that street and alley easement deed of ODMARK/WELCH; and

WHEREAS, the City desires to reserve a certain easement for San Diego Gas & Electric Company for electrical facilities over a portion of Camino De La Plaza to be vacated; and

WHEREAS, those properties adjoining those portions of Camino De La Plaza, Virginia Avenue and Alley to be vacated will continue to have access or will be accessible by the streets and alley which have been dedicated with the approval on this date of the acceptance of that street and alley easement deed of ODMARK/WELCH; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That portions of Camino De La Plaza, Virginia Avenue and Alley, as more particularly shown on Drawing No. 14982-B on file in the office of the City Clerk as Document No. Re- 253530 which is by this reference incorporated herein and made a part hereof, be, and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that the City reserves and excepts from the foregoing vacation, a permanent easement for electrical facilities, as more particularly shown on Drawing No. 14982-B on

file in the office of the City Clerk as Document No. $\frac{RR-253530}{}$.


BE IT FURTHER RESOLVED, that The City of San Diego hereby reserves and excepts from vacation and abandonment, easements and rights of any public utility pursuant to any existing franchise or renewals thereof, at any time, or from time to time, to construct, maintain, operate, replace, remove, renew and enlarge overhead or underground lines of pipe, conduits, cables, wires, poles and other structures, equipment and fixtures for the transportation or distribution of electrical or electronic energy and natural gas and for incidental purposes including access to protect the property from all hazards in, upon, over and across the above described portions of streets to be vacated and abandoned.

That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
