

RESOLUTION No. R- 253531 (R-81-1303)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street easement deeds of MCKELLAR DEVELOPMENT CORPORATION, an Oregon corporation, and MCKELLAR AND ASSOCIATES, a California corporation, executed in favor of The City of San Diego, bearing date of December 3, 1980, copies of which are on file in the office of the City Clerk as Documents No. RR- 253531 -1 and RR- 253531 -2, granting to said City an easement for a right of way for a public street on portions of Lots 4, 5, 6 and 11 of La Jolla Village Park Unit No. 1, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named NOBEL DRIVE.

That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
