## A RESOLUTION OF INTENTION TO MAKE CHANGES AND MODIFICATIONS

CAMINO DEL RIO SOUTH, TEXAS STREET TO I-805  
ASSESSMENT DISTRICT

RESOLVED, by the City Council of the City of San Diego, California, that the public interest, convenience and necessity require, and that it is the intention of said Council to make changes and modifications in the assessment filed pursuant to Resolution of Preliminary Determination and of Intention No. R-151941 adopted by this Council on October 27, 1980, by increasing the assessments set forth on the Exhibit hereto attached to reflect certain higher costs and to apportion and distribute said costs according to benefits. The Engineer shall make said changes either on the face of the assessment or by filing an amendment thereto.

The Special Districts Secretary, Engineering and Development Department of said City be, and is hereby designated as the department to answer inquiries regarding any protest proceedings to be had herein, and may be contacted during regular office hours at the City Operations Building, 1222 1st Avenue, San Diego, California, or by calling (714) 236-7056 or 236-5735.

The City Clerk of said City shall cause a copy of this Resolution to be published once in the San Diego Daily Transcript, a newspaper of general circulation published in said City of San Diego and the paper in which the Notice of Improvement under said Resolution of Intention was published, and to be mailed to all property owners whose assessments are increased, said publication to be at least ten (10) days before said day of hearing, and said mailing to be at least twenty (20) days prior to said hearing date.
