BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized to execute, for and on behalf of said City, an agreement with GEORGE S. NOLTE & ASSOCIATES, a California corporation, to provide professional engineering services for design of improvements for Sunset Cliffs Boulevard drain and Myrtle Canyon drain, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-253578.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$1,500 from CIP No. 90-245(1), Capital Outlay Fund Reserve 30245, to CIP No. 11-191 Myrtle Canyon Drain, and the sums of \$4,700 are hereby authorized from CIP No. 11-164 and \$5,300 from CIP No. 11-191, Capital Outlay Fund, for the sole and exclusive purpose of providing funds for the above services.
