BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an Amendment to Agreement with the STATE OF CALIFORNIA, DEPARTMENT OF TRANSPORTATION, for participation in the modification of the traffic control signal system, construction of right-turn channelization and wheelchair ramps at the intersection of Nimitz Boulevard and Rosecrans Street (State Route 209), under the terms and conditions set forth in the Amendment to Agreement on file in the office of the City Clerk as Document No. RR-253581.

BE IT FURTHER RESOLVED, that the expenditure of \$5,700 is hereby authorized from CIP 68-001, Capital Outlay Fund 30245, solely and exclusively to increase the City's 50% share of the project cost from \$17,100 to \$22,800.
