RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE PLAN FOR ACQUISITION
FROM THE SECOND BOND ISSUANCE OF THE SAN DIEGO
OPEN SPACE PARK FACILITIES DISTRICT NO. 1

WHEREAS, the voters approved Proposition C in June of 1978 for the purpose of purchasing open space, utilizing revenues from general obligation bonds; and

WHEREAS, the City staff has utilized proceeds from the first bond issuance to purchase said open space in accordance with City Council adopted priorities; and

WHEREAS, it is desirable to continue acquisition of open space lands; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that a proposed Acquisition Plan for the properties which may potentially be acquired with the proceeds of San Diego Open Space bonds, Series 81A (\$15 million), a copy of which Acquisition Plan is on file in the office of the City Clerk as Document No. RR-253585, is hereby approved.

BE IT FURTHER RESOLVED, that said Acquisition Plan has been compiled for planning purposes only and is subject to change at any time by future Council resolution as a result of market conditions, change in priorities or any other factors determined significant by the City Council.

BE IT FURTHER RESOLVED, that persons owning properties shown on the Acquisition Plan shall not be adversely affected by adoption of the Acquisition Plan and shall continue to have

the right to utilize and develop their properties subject to zoning and other restrictions imposed by law.
