
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with LEIGHTON AND ASSOCIATES, INCORPORATED, to provide professional engineering services in connection with the investigation of the Sonico landslide, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-253588.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$25,000 is hereby authorized from Sewer Revenue Fund (41506) solely and exclusively for the above services.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$25,000 within Sewer Reserve Fund (41506) from the Unallocated Reserve (70697) to Sewer Engineering Services (70641) to provide funds for said services.
