WHEREAS, the fiscal outlook for The City of San Diego is of such consequence as to require significant analysis of current and future staffing levels; and

WHEREAS, to achieve and maintain fiscal responsibility and comply with the constraints of state and local spending limitations, it may be appropriate to take immediate action in respect to reductions in expenditures; and

WHEREAS, to that end, it would seem prudent to follow the example of the President in imposing a selective hiring freeze; and

WHEREAS, further in that regard, this Council encourages the City Manager and independent department heads to exercise prudence in hiring personnel; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby directed to employ the same procedure for selective hiring as he did in fiscal year 1980 in the approval process for hiring in managerial departments.

BE IT FURTHER RESOLVED, that independent department heads are encouraged to retain at the highest level in their respective departments the hiring authority for new employees.
