PISOR, executed in favor of The City of San Diego, bearing date of December 22, 1980, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 253621, granting to said City an easement for public street purposes over, along and across a portion of "G" Street vacated and in portion of Lot 9, E. W. Morse Subdivision of Pueblo Lot 1150, Map 547, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named 30TH STREET.
