That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with BLACK & VEATCH for engineering services in connection with an industrial pretreatment program for the South Bay Wastewater System and Related Facilities at a cost not to exceed \$37,454.00, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-253623.

BE IT FURTHER RESOLVED that the Auditor is hereby authorized to transfer the sum of \$37,454.00 within Sewer Revenue Fund 41506 from the Unallocated Reserve (70697) to Industrial Waste Control (70215), solely and exclusively for the purpose of providing funds for the above services.
