City of San Diego, et al. (U.S.S.Ct. Case No. 80-195) and City of San Diego, et al. v. Metromedia, Inc. et al. (U.S.S.Ct. Case No. 80-196); and

WHEREAS, associate counsel, brief and travel expenses in connection with the above-cited cases have exceeded initial estimates due to the magnitude of the issue and the fact that additional appearances and information have been requested by the Supreme Court; and
