WHEREAS, on November 25, 1980, the City Council, by **FEB 17 1981**
Resolution No. 253182, authorized the transfer of \$4,000 from the
Unallocated Reserve to the Allocated Reserve for the purpose of
incurring expenses in connection with the billboard litigation
before the United States Supreme Court entitled Metromedia, Inc.
et al. v. City of San Diego, et al. (U.S.S.Ct. Case No. 80-195)
and City of San Diego, et al. v. Metromedia, Inc. et al. (U.S.S.Ct.
Case No. 80-196); and

WHEREAS, associate counsel, brief and travel expenses in
connection with the above-cited cases have exceeded initial
estimates due to the magnitude of the issue and the fact that
additional appearances and information have been requested by
the Supreme Court; and

WHEREAS, in order to pursue the above-cited cases to a
successful conclusion, it is now necessary to augment said
Resolution No. 253182 in the sum of \$5,000 to accommodate
further travel and associate counsel expenses; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that the City Auditor and Comptroller be and he is hereby
authorized to transfer the sum of \$5,000 within the General
Fund 100 from the Unallocated Reserve (605) to the Allocated
Reserve (901) for the sole and exclusive purpose of supplementing
