BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Auditor is hereby authorized to transfer \$121,600 from CIP 52-189, Smythe Avenue, Beyer Boulevard and Picador Boulevard, to CIP 90-245, Capital Outlay Unallocated Reserve.

BE IT FURTHER RESOLVED, that the Auditor is hereby authorized to transfer \$100,000 from CIP 90-220, Gas Tax Unallocated Reserve, to CIP 52-189, Smythe Avenue, Beyer Boulevard and Picador Boulevard.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$60,000 from Gas Tax Funds, for right-of-way acquisition and relocation costs for Smythe Avenue, CIP 52-189 now known as Smythe Avenue/Beyer Boulevard and Picador Boulevard Project, which amount is needed to supplement the appropriations authorized in Resolutions 216545 and 251164, adopted in January, 1980, is hereby authorized and approved.
