BE IT FURTHER RESOLVED, that the Personnel Director be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Second Amendment to Agreement with the SAN DIEGO REGIONAL EMPLOYMENT AND TRAINING CONSORTIUM (RETC) to extend the CETA Title VI agreement through September 30, 1981, at the existing funding level pursuant to the terms and conditions of the Second Amendment to Agreement on file in the Office of the City Clerk as Document No. RR- 253626-2 .

BE IT FURTHER RESOLVED, that the Personnel Director be, and he is hereby authorized and empowered to execute and modify as necessary, for and on behalf of said City, agreements with the following agencies for the operation of Public Service Employment Programs pursuant to the Comprehensive Employment and Training Act (P. L. 95-524), Title II-D and Title VI, for


