

RESOLUTION NO. R-253655

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the street to be vacated constitutes excess width; and

WHEREAS, a portion of 36th Street between "K" and "L" Streets and adjacent to Lots 7 through 9, Block 73, Homestead Union, Map 363 has been determined to be excess since the portion of the street to remain after vacation will be sufficient in width to satisfy the public needs; and


WHEREAS, those properties adjoining the streets to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the excess width in a portion of 36th Street between "K" and "L" Streets and adjacent to Lots 7 through 9, Block 73, Homestead Union, Map 363, as more particularly shown on Drawing No. 15012-B on file in the office of the City Clerk as Document No. RR-253655-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

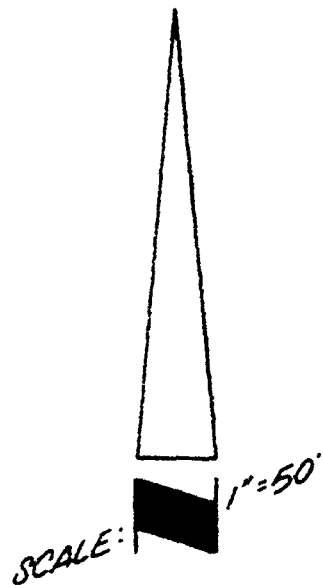

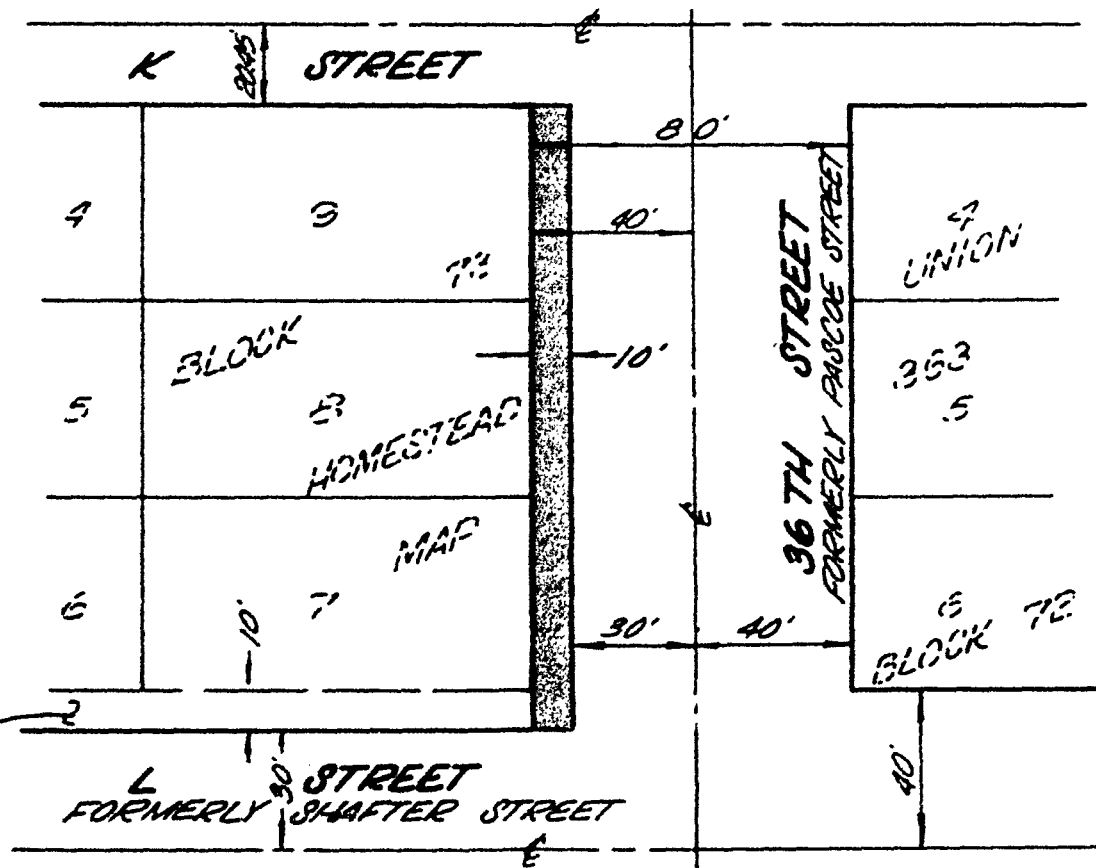



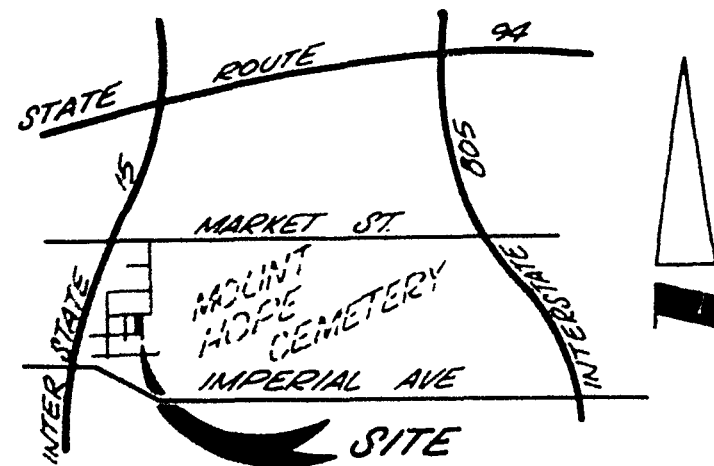
