

RESOLUTION NO. R- 253657

(R-81-1390)

WHEREAS, in September, 1977 the City of San Diego established the 395-foot elevation contour line around Mule Hill near Lake Hodges as a portion of a lease boundary and 1"x 18" pipes were set at intervals along the line to define its shape; and

WHEREAS, an approximate 395-foot contour line had previously been surveyed and shown on Subdivision Map 7756 which is similar to the City line except that it is slightly higher in elevation, thus creating a small hiatus of approximately 9 feet between the two lines; and

WHEREAS, a Record of Survey has been prepared which shows both lines and since the City has established its own line, the uphill private land owners have requested that the City recognize it as the 395-foot contour line; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, the Record of Survey on file in the office of the City Clerk as Document No. RR- 253657-1, agreeing that the City of San Diego will recognize its established 395-foot contour as the limits of its ownership.

BE IT FURTHER RESOLVED, that the Mayor and City Clerk are hereby authorized and empowered to execute five quitclaim deeds, quitclaiming to DENNIS L. WELLS and NORALEE J. WELLS, husband and wife; ROLAND H. JENSEN and MARGARET I. JENSEN, husband and wife; ROBERT C. RILEY and JANE B. RILEY, husband and wife and REGINALD EDWARD L'ABBE, a single man; DANTE DICICCO and EVE DICICCO, husband and wife; DAVID W. HYLEN, a single man, and KELLY M. SCHECTER, a single woman; the City's right, title and interest in and to that real property situated in the County of San Diego, State of California, as more particularly described in the quitclaim deeds

on file in the office of the City Clerk as Document Nos. RR-253657-2,
RR-253657-3, RR-253657-4, RR-253657-5, RR-253657-6,
respectively.

BE IT FURTHER RESOLVED, that the City Clerk shall cause said deeds and a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
