That the expenditure of \$77,800 from Capital Outlay Fund #30245, \$19,000 from Water Revenue Fund #502 and \$6,000 from Sewer Revenue Fund #506, of The City of San Diego, be hereby authorized, solely and exclusively, for the purpose of accomplishing Radio Communications Systems Improvement Projects C.I.P. #37-146, 37-147.1, 37-148, 43-006 and 73-006.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work for accomplishing Radio Communications Systems Improvement Projects C.I.P. #37-146, 37-147.1, 37-148, 43-006 and 73-006, pursuant to the recommendation of the City Manager and submission of estimates by him indicating that said work can be done by City forces more economically than if let by contract.
