

RESOLUTION NO. R-253662

(R. 81-1435)

WHEREAS, Curie Way is a cul-de-sac residential street with no through traffic and no legal driveways abutting the street; and

WHEREAS, all the abutting property owners utilize vehicular access through an unnamed alley behind their properties; and

WHEREAS, the abutting property owners have requested that the City barricade Curie Way since it has been the scene of vandalism and late-hour disturbances; and

WHEREAS, City staff has reviewed the proposal and determined that barricading Curie Way would not create any traffic problem; and

WHEREAS, the Fire, Police and General Services Departments have no objections to the erection of a barricade so long as a gate with a lock is provided for emergency and maintenance vehicle access; NOW, THEREFORE,

BE IT RESOLVED that, pursuant to the provisions and authority contained in Section 21101 of the Vehicle Code of the State of California, the City Council hereby determines that Curie Way is no longer needed for vehicular traffic.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to cause an appropriate barricade to be erected across Curie Way.

BE IT FURTHER RESOLVED, that this resolution shall be subject to review from time to time by the City Council and may
