WHEREAS, in that solicitation, interested personnel were advised that such suggestions would be screened by the Council Rules Committee for sponsorship in the 1981 State and Federal Legislatures; and

WHEREAS, the Council Rules Committee considered those resultant legislative proposals on February 2, 1981 and agreed to support seven proposals for bill sponsorship; and

WHEREAS, the Rules Committee is now recommending to the full City Council a resolution in support of those seven sponsorship programs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby declares its support of seven proposals received and reviewed pursuant to the City's 1981 Sponsorship Program, said proposals set forth with greater specificity in that sponsorship program package on file in the office of the City Clerk as Document No. RR-253665.
