

3E IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. INTERNATIONAL HARVESTER CO., 2. CARMENITA FORD TRUCK SALES, INC., 3. GMC TRUCK & COACH DIVISION, 4. CENTER CITY FORD and 5. FULLER FORD INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MEDIUM AND HEAVY DUTY TRUCKS as follows:

- 1. INTERNATIONAL HARVESTER CO. for Item 1 Three (3) each eight (8) cu. yd. dump truck complete with dump body (International model F-1954) at a cost of \$36,820.78 each; Item 6 One (1) four-wheel drive dump truck complete with five (5) cu. yd. body (International model 1854 4 x 4) at a cost of \$32,210.45; Item 7 One (1) tandem axle truck diesel powered complete with 12 yd. dump body (International model F 4370) at a cost of \$58,310.40; Item 14 Four (4) each 22,000 lb. GVW cab and chassis with tilt cab (International model CO-1610B) at a cost of \$15,440.45 each, for a combined total cost of \$262,744.99; terms net 30 days, plus sales tax.
- 2. CARMENITA FORD TRUCK SALES INC. for Item 2 Three (3) each 27,000 lb GVW semi-trailer tractor complete with fifth wheel (Ford model F700) at a cost of \$15,762.34; Item 9 One (1) 24,000 lb. GVW cab and chassis (Ford model F700) at a cost of \$14,264.96; Item 11 Two (2) each 26,000 lb. GVW cab and chassis (Ford Model F700) at a cost of \$14,696.04 each; Item 12 One (1) 24,000 lb. GVW cab and chassis (Ford model F700) at a cost of \$11,345.89; Item 16 One (1) 27,000 lb. GVW cab and chassis (Ford model F700) at a cost of \$14,897.60; for a combined total cost of \$117,187.55; terms net 30 days, plus sales tax.
