BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$24,000 from Fund 18516, Department 5970, Organization 7001 (CDBG Contingencies) to Fund 18516, Department 5964, Organization 6406 (Inner City Self-Help Project), for the above purpose.
