BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Property Department is hereby authorized to purchase the 1.75 acre site located at 35th Street and Oceanview Boulevard (Parcel Number D.D. 18148-01-01, Map L.O. 55502) from the California Department of Transportation for a sum not to exceed \$155,000.

BE IT FURTHER RESOLVED, that the expenditure of \$110,000 from Community Development Block Grant Fund 18516, Dept. 5965, Org. 6504, be hereby authorized, solely and exclusively, for the purpose of acquiring land for Fire Station No. 19.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, be and he is hereby authorized to transfer within Community Development Block Grant Fund 18517 from Dept. 5994, Org. 9401 (Contingency) to Dept. 5988, Org. 8815 (Fire Station No. 19), the sum of \$45,000 and the expenditure of such sum, solely and exclusively for the above purpose be hereby authorized.
