A RESOLUTION OF THE CITY COUNCIL AMENDING THE CAPITAL IMPROVEMENTS PROGRAM, BY AMENDING DOCUMENT NO. 00-15298-1, AS AMENDED, BY ADDING PROJECT NO. 52-298, ENTITLED "MISSION BOULEVARD LANDSCAPING," TO THE FISCAL YEAR 1981 CAPITAL IMPROVEMENTS PROGRAM; AUTHORIZING AND DIRECTING THE AUDITOR AND COMPTROLLER TO TRANSFER FUNDS IN THE SUM OF \$238,000; AND DIRECTING THE CITY MANAGER TO TAKE THOSE STEPS NECESSARY TO BRING ABOUT A PUBLIC HEARING ON THE ESTABLISHMENT OF A MAINTENANCE DISTRICT FOR THE FUNDING OF THE MAINTENANCE OF LANDSCAPING TO BE INSTALLED UNDER THIS PROJECT.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 2, subsection 29 of the annual appropriation ordinance, the Capital Improvements Program as contained in Document No. 00-15298-1, as amended, be and the same is hereby futher amended by adding C.I.P. Project No. 52-298, Mission Boulevard Landscaping, to the fiscal year 1981 C.I.P. Program.

2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$238,000 from C.I.P. 53-021 (Fiesta Island Road) Fund 30244 to C.I.P. 52-298 (Mission Boulevard Landscaping).

3. That the City Manager be and he is hereby directed to take those steps necessary to bring about a public hearing on the establishment of a maintenance district for the funding of the maintenance of landscaping to be installed under this project. The public hearing on the district is to be scheduled with the award of the landscaping contract.
