

RESOLUTION NO. R-253678Adopted on FEB 24 1981

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Ernest C. Salgado	Police	\$ 2,500	Mr. Salgado is a Police Officer. He suggested that a stolen/missing item report be added to the Police crime report. This greatly reduces investigation time when there are additions or changes to property information. This is a partial award pending a final 12-month review. Estimated first year's savings are \$45,616.
Wayne L. Ramsey Alvin A. Beckett	City Treasurer Police	\$ 1,000	Mr. Ramsey is a Supervising Field Representative, and Mr. Beckett is a Sergeant. They suggested the implementation of a delinquent fee schedule for Business Licenses. The estimated additional revenue as the result of their suggestion is \$70,000.
Joseph J. Scelso	Police	\$ 950	One year ago Mr. Scelso earned a partial award of \$50 for his suggestion to rearrange the physical testing procedure for Police recruits. One year's experience has shown a first year's savings of \$21,566. This is the remainder of Mr. Scelso's award.
Gordon G. Redding	Police	\$ 865	One month ago Mr. Redding earned a partial award of \$200 for his suggestion to eliminate victim notification cards. An updated evaluation showed an estimated increase in savings \$7,097. This is an additional partial award.
Dennis L. Marnell	General Services	\$ 605	Mr. Marnell is an Equipment Mechanic in the Equipment Division. He suggested that bolts attaching transmissions to refuse trucks be replaced with longer bolts. This prevents transmission repairs and is expected to save \$4,044. This is a partial award pending a final 12-month review.
