

RESOLUTION NO. R-253679Adopted on FEB 24 1981

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Caroline L. McCullagh	Building Inspection	\$ 305	Ms. McCullagh is a Building Inspection Technician II. She suggested that waiting areas for Zoning and Building Inspection counters be relocated. This saves an estimated \$2,324 annually in space requirements. This is a partial award pending a final 12-month review.
Larry L. Griffin	Police	\$ 285	One year ago Mr. Griffin earned a \$280 partial award for his suggestion to implement a system of scheduled, periodic taxicab inspections. One year's experience has shown a savings of \$5,643. This is the remainder of his award.
Thomas A. Wormington George M. Harkleroad	General Services	\$ 225	One year ago Mr. Wormington and Mr. Harkleroad earned a \$70 award for their suggestion to use self-energizing exit lights in City facilities. One year's experience has shown a savings of \$2,940. This is the remainder of their award.
Robert L. Davis	General Services	\$ 210	Mr. Davis was a Plumber in the Buildings Division at the time of his suggestion. He suggested that a flow switch be installed in the water make-up line to the boiler at the Fine Arts Gallery. This is expected to save \$1,382 annually in repair and maintenance costs. This is a partial award pending a final 12-month review.
An Gia Vu	Water Utilities	\$ 195	Mr. Vu is a Water Plant Operator in the Quality Division. He developed a device to detect sludge elevation in reactors or basins. This prevented the purchase of a factory made indicator. Savings are \$644.
