

RESOLUTION NO. R-253680Adopted on FEB 24 1981

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Timothy L. O'Connell	Planning	\$ 150	Mr. O'Connell was an Assistant Planner at the time of his suggestion. He suggested that mailing draft Environmental Impact Reports and Negative Declarations to the public be eliminated. This saves \$1,500 annually in processing costs.
Robert C. Nightingale	Planning	\$ 115	Mr. Nightingale is a Zoning Representative. He suggested that the logging of mail be eliminated in the Zoning Division. This saves \$1,147 annually in processing costs.
Blanche Solow	Police	\$ 85	Ms. Solow is an Intermediate Typist. She suggested that the printing, storing, filing and purging of identification cards on moving and parking citation books be eliminated. This saves an estimated \$560 annually in processing costs. This is a partial award pending a final 12-month review.
Harry J. Keehan	Library	\$ 70	One year ago Mr. Keehan earned a \$50 partial award with his suggestion to purchase an automatic dialing system for the Directory Desk. One year's experience has shown a savings of \$1,205. This is the remainder of his award.
Inge Davidson	Risk Management	\$ 20	Ms. Davidson was a Claims Representative II at the time of her suggestion. She suggested that awards approved by the Workers' Compensation Appeals Board be logged on Control Cards. Savings could not be calculated, but his was considered to be a significant operational improvement.
