Thomas W. Dush	Fire	\$ 20	Mr. Dush is a Fire Fighter. He suggested that cap nuts be installed on fire engine side view mirrors. Savings could not be calculated, but this was considered to be a significant safety improvement.
Madelyn L. Leibold	Planning	\$ 15	Ms. Leibold is a Zoning Representative. She suggested that 100' scale maps be eliminated for no hearing variances. This saves \$163 annually in processing costs.
Kris A. Barnett Donna M. Olszewski	Engineering & Development	\$ 10	One year ago Ms. Barnett and Ms. Olszewski earned a \$95 award for their suggestion to use a new method of preparing patch changes for map books. One year's experience has shown a savings of \$1,046. This is the remainder of their award.
