WHEREAS, The City of San Diego is the owner of a portion of the Southwest Quarter of Quarter Section 71, Rancho de la Nacion, and adjacent slope easement; and

WHEREAS, the City desires to negotiate the sale of said land to THE VILLAGE COMPANY, a joint venture, under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
