SAN DIEGO APPROVING THE APPLICATION AND THE
PROJECT AGREEMENT FOR HISTORIC PRESERVATION
GRANTS-IN-AID FUNDS FOR THE SPRECKELS ORGAN
PAVILION PROJECT.

WHEREAS, the Congress under Public Law 89-665 has authorized the establishment of a National Historic Preservation Grants-in-Aid Program, providing matching funds to the State of California and its political subdivisions for historic preservation, survey, planning, development and acquisition projects; and

WHEREAS, the State Department of Parks and Recreation is responsible for the administration of the program within the state, setting up necessary rules and procedures governing application by local agencies under the program; and

WHEREAS, said adopted procedures established by the State Department of Parks and Recreation require the applicant to certify by resolution the approval of applications and the availability of local matching funds prior to submission of said applications to the state; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby:

1. Endorses and approves the application filed by the Committee of 100 for the National Historic Preservation Grants-in-Aid assistance in the amount of \$50,000 for the Spreckels Organ Pavilion project.

2. Appoints the City Manager or his authorized deputy as agent of the City to coordinate, process and execute all contracts, agreements, amendments and ancillary documents within the scope of the application which may be required to implement the project.

3. Agrees to accept the proceeds of said grant and agrees to accept an additional \$50,000 from the Committee of 100.
