BE IT RESOLVED, By the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those easement deeds of GENSTAR DEVELOPMENT, INC., a New York corporation, and COLADA CORPORATION N.V., a Netherlands Antilles corporation, executed in favor of The City of San Diego, bearing dates of October 8 and November 11, 1980 and February 3, 1981, copies of which deeds are cumulatively on file in the Office of the City Clerk as Document No. RR- 253733-1, 253733-2 & 253733-3, granting to said City easements for public street and storm drain purposes, over, under, along and across a portion of the Southwest Quarter of Section 10, Township 15 South, Range 3 West, as shown on Record of Survey 7775 filed in the Office of the County Recorder, and as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named MIRAMAR MALL.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
