
BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the acceptance by the City Manager of those easement deeds of MIDWAY DRIVE-IN THEATRE, a California corporation, executed in favor of The City of San Diego, bearing date of January 21, 1981, copies of which are on file in the office of the City Clerk as Documents No. RR- 253728⁻¹ and No. RR- 253728-2 granting to said City easements for public street purposes and water and electrical facilities over, under, along and across all that portion of Lots 1 and 2 of the Partition of Pueblo Lot 219 of the Pueblo Lands of San Diego, as more particularly described in said deeds, be and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street and Parcel 1 is hereby named WEST POINT LOMA BOULEVARD, and Parcel 2 is hereby named SPORTS ARENA BOULEVARD.

That the City Clerk is hereby authorized and directed to cause said deeds and a certified copy of this resolution attested by him under seal to be recorded in the office of the County Recorder.
