

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with LOWRY & ASSOCIATES, a California corporation, to provide professional engineering services for a downtown drainage study to investigate and determine the adequacy and structural integrity of downtown drainage facilities, with particular emphasis on the "B" Street conduit, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-253742.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$25,000 from Fund 18516, Dept. 5970, Org. 7001 (Contingencies) to Fund 18516, Dept. 5965, Org. 6514 (Downtown Drainage Study); and the expenditure of said sum is hereby authorized out of the Downtown Drainage Study Fund, solely and exclusively to fund this project.
