That Change Order No. 1, dated February 6, 1981, heretofore filed with the City Clerk of said City as Document No. RR-253745, issued in connection with the contract between The City of San Diego and Parnell and Leonard, Inc. for CONSTRUCTION OF SWIMMING POOLS RETROFIT FOR SOLAR HEATING, said contract having been filed in the office of the City Clerk as Document No. 252133, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$30,000, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$30,000 is hereby authorized from Park Service District Funds: 15630 (\$7,549); 15633 (\$13,753); 15650 (\$5,297); 15652 (\$1,401); and 13470 (\$2,000), to supplement Resolution No. R-251632, solely and exclusively for this purpose.
